

PETITION FOR COURT AUTHORIZATION FOR THE MARRIAGE OF A MINOR

Use this packet only if the following statements are true:

- The minor is 17 years old.
- The minor has the consent of either parent or the minor's legal guardian.
- The minor **and** the desired spouse are residents of the State of Nevada.
- The judge should allow the minor to marry because extraordinary circumstances exist.

This packet contains the following forms:

1. Petition for Court Authorization for the Marriage of a Minor
2. Declaration of Resident Witness (for minor)
3. Declaration of Resident Witness (for proposed spouse)

Complete the forms:

- ✓ Carefully read through the forms and neatly print the requested information legibly in ink.
- ✓ Make 1 copy of the documents for your records prior to filing.
- ✓ Bring both the original and copy of the documents to the District Court Clerk's Office on 3rd floor for filing.
- ✓ Filing fee of \$265.00 is required.
- ✓ If you cannot afford the fee, you may apply to have it waived. Complete the *Application and Order to Proceed in Forma Pauperis* forms and submit them along with the above listed forms.

Once a court order authorizing the marriage of a minor has been entered, you must bring a **certified copy of the Order** to the Clerk-Recorder Marriage Department to obtain a marriage license.
